On Tues., 7-23-91, I, Det. KENNEDY, on Squad 126, along with Det. Michael responded to 924 N. 25th St., #213, to investigate. Upon our arrival, we were met Squads 31-P.O. RAUTH and MUELLER, who state that at approximately 11:25PM, they were flagged down by an individual who had a handcuff on and stated that a man had threatened him with a knife in Apt. #213 at the apartment building 924 N. 25th St. They state at this time, they proceeded to that apartment and upon knocking on the door, they allowed to enter the suspect's dwelling and began to question him. During question they state they observed several polaroid photographs which showed mutilation of human bodies and human heads. They state at this time they placed the individual under arrest for the attempted homicide regarding the individual, Tracy EDWARDS, who flagged them previously and called for the CIB.

At this time I rode along with the suspect, Jeffrey L. DAHMER in Squad 93, to the CIB. Once at the CIB, I advised Jeffrey L. DAHMER of his constitutional rights. He stated that he fully understood them and that he wished to freely make a statement regarding the incident. At this time Mr. DAHMER states that he is 31 years of age, in Milwaukee, WI. He states he moved to Richfield, Ohio, when he was about 6 years old and he was raised there and attended and graduated from Revere High School. He stated he spent three years in the army after graduation and moved back to Milwaukee when he was approximately 23 or so years old. The subject states he has a father who lives in Pennsylvania and a mother who lives in California. He states he has one brother, 2 living in Cincinnati, and his grandmother on his father's side lives in Milwaukee. Subject states he was raised in the Protestant faith as he was growing up, but he now considers himself to be an atheist. He admitted that he had been arrested in the past and states he is currently on probation for taking polaroid pictures of a minor. Subject states that when he was 18 years of age and living in Richfield, Ohio, he picked up a hitchhiker whom he described as a white male about 19 years of age. He states he took the hitchhiker and had homosexual sex with him and states they were drinking beer and became intoxicated. He states they got into a physical fight because the 19-year old individual tried to force sex on him and that during the fight, he states he struck the hitchhiker with a barbel. He states that the blow of the barbel caused the death of the hitchhiker, and at this time he
